I would like to address the petition you received from the "Concerned Citizens of Meridian". This petition demands a vote to dissolve the district due to allegedly providing minors "access to obscene and sexually explicit materials," among other concerns.

First, I would like to submit a defense for libraries.

Public libraries are a vital part of communities and provide access to a vast range of resources and services that greatly benefit our residents of Meridian and Ada County as a whole. From being able to freely access books and movies, to technology and educational programs and classes, to providing a safe space for todays youth to build communities through events like the After School Hangouts or Chess clubs, the library helps promoting community, literacy, furthering education and most importantly, providing free access to vast amounts of information. Removing this service would greatly hinder and hurt our community.

Historically, we can look back at governments or institutions that have tried to suppress access to information, and we can learn a lot through how those governments or organizations operated. Famously, the Nazi Party burned books they disagreed with or were deemed "un-German" which included books from liberal/leftist authors and Jewish authors. This makes sense, as one of the main ideas of fascism (which the Nazi party embodied) is the forcible suppression of opposition. I am not calling the Concerned Citizens of Meridian fascists; however, they are employing a fascist strategy to suppress information that they personally do not like. These strategies are un-American and need to be fought.

Libraries are a gathering of all sorts of information and they do not discriminate based on the content. A quick search of the Meridian Library proves this. I was able to find copies of Mein Kampf, The Communist Manifesto, Atlas Shrugged, and books written by notable right-wing personalities such as Tucker Carlson and Ben Shapiro. Providing opposing viewpoints is vital to a well-functioning society, and helps to create a well-read and well-informed populace. The banning of books, or in this case, the shut down of a library, actively prevents this.

Now, to address the Concerned Citizens of Meridian's arguments.

From news articles discussing this, specifically from KTVB, it appears they are largely concerned about minors accessing 'obscene and sexually explicit materials.' I do believe there are some materials that may be harmful to minors, and understand their concerns. However, the responsibility of monitoring what type of content minors consume does not fall on public libraries, but rather the parents. If parents are concerned about their child's media consumption, they must perform their job as a parent and monitor what content is allowed. Further, it's clear that groups like the Concerned Citizens of Meridian are using language such as 'obscene and sexually explicit' to really mean any books or materials that discuss LGBTIA+ topics. This is a blatant attempt at trying to suppress information or resources for an already discriminated against group of people.

I vehemently oppose and disagree with the petition put forth and believe that dissolving the Meridian Library District would have negative and long-term consequences. It would set a terrible precedent not just for Ada County, but for the state of Idaho and the rest of the U.S. The arguments put forth by this group of citizens is done in bad faith, and is a continued effort from radical right-wing groups to restrict the flow of information regarding topics they disagree with, in this case the very existence of LGBTIA+ peoples. This is proven if you look back at the list of 54 books a Meridian group wanted to be banned from circulation to minors. The most common reason on this list was LGBTIA+ content. This was blatant discrimination, and this same thought process is the driving force behind the recently submitted petition.

Dissolving the entire district is not a reasonable request and should not be considered. This is a drastic measure that would deprive Meridian and Ada County residents of essential resources and services. I strongly urge you to reject this petition to dissolve the Meridian Library District. There may be actual concerns this group presents, but there are ways to address those concerns that do not include the full closure of the Meridian Library District.

I would like to end this with a quote from Meridian Library Director Nick Grove from November 2022: "You have the right to object to an item. You have the right to recommend a reconsideration of an item that you don't like. You do not have the right to ban books or segregate access to books that you do not want."

I fully support this quote, and hope that you will determine that the banning of books or shut down of a whole library district is a drastic measure that should be avoided.



As a member of the Meridian community, a former Ada County employee, and the owner of an independent bookstore in Meridian, I felt compelled to add my voice to the overwhelming response.

Ten-mile and Cherry use to be all fields, I grew up smelling the sweet scent of mint from our backyard. We didn't have a fence for the longest time, and the farmer didn't mind us running through his fields along the canal gathering corn, onions, or whatever he was growing that season. My parents didn't worry about us running off to the rickety tree house we built in a tall oak bordering the field, they knew we were safe. Meridian is and forever will be my home, but our home is growing and rapidly changing.

I have a family of my own now, and I was fortunate enough to purchase the same home I grew up in off of Ten-Mile and Cherry road. I held expectations of my children making the same beautiful memories, but that field is now a new neighborhood, our treehouse is gone, and we built a fence. A part of me is sad and disappointed, but we learn to adapt, Meridian is still our home.

Even though there is so much change happening around us, The Meridian Library has been a reliable memory. It has been in the same location for as long as I can remember, I am thirty now, and I still remember browsing the aisles for hours. Growing up I wasn't the most vocal or social child, books were my solitude. As I ran through story after story, my family didn't have the funds to constantly purchase new books for my collection, but the Library was always there.

I discovered worlds beyond my imagination among those aisles. My love for adventure grew as I read through pages of Frodo's bravery in the Lord of the Rings by J.R.R Tolkien. As I read Ella's confidence in Ella Enchanted by Gail Carson Levine, my own confidence blossomed. I discovered magic with Harry in Harry Potter by J.K Rowling. I laughed with Westly and Buttercup through The Princess Bride by William Goldman. And I cried reading the heartbreak of Nick Carraway in The Great Gatsby by F. Scott Fitzgerald. Books are endless wells of emotions and lessons.

I am reaching out on behalf of myself and the community of Meridian when I say that I ardently oppose the petition to dissolve the Meridian Library District. The greatest gift of my childhood was the proximity of my local library. When I got my first library card it felt like a rite of passage. Over my lifetime I have checked out everything from non-fiction books about animals, how-to arts and crafts books, chapter books, movies, magazines... the list goes on. I have taken advantage of their quiet study spaces, computers, their access to the internet, online peer reviewed journal articles, etc. etc. I regularly attended the various kids and teen programs and still continue to participate in their summer reading programs. Beyond the material benefits the library offers, the librarians that I have grown to know as my friends have had an equally positive experience in my life.

While this is my personal experience, I know many other library patrons share an equal appreciation and positive experience from their local libraries. Over the past several months I have spent the time researching the motivations behind book bans in our country and more specifically on a local level. I have read nearly all of the books from Nampa School Districts' 2022 book ban, and while I can understand how some parents may be uncomfortable with their children reading such material, to say that NO child, teen, or adult should have access to these books is a great disservice.

Enclosed you will find the above-named petition with the appropriate number of verified signatures as per Idaho Statutes 33-2713 and 33-2704. We <u>do not take lightly</u> the submission of this petition to the Ada County Commissioners. However, all other avenues of verbal discourse with the Meridian Library District Trustee Board and Library Director have, from our perspective, been exhausted.

The focus of our efforts since early 2022 is the <u>segregation and labeling</u> of books containing obscene and sexually explicit material (samples enclosed) from direct access by minors. One of the newly appointed trustees is an employee of the MLD trustee board chairman who works at COMPASS; a strategy to continue the perpetration of their strategy to load the trustee board with "friendly's".

In Nov. 2022, the MLD library director announced that they would <u>discontinue public</u> <u>discourse or comments at their monthly meeting</u> until further notice, only comments by email. From our perspective, that <u>is taxation without representation</u>; that was the last straw for us.

Citizens' group seeks to dissolve Meridian library district

A group of Ada County residents wants to dissolve the Meridian Library District.

The group, Concerned Citizens of Meridian, filed a petition with the Ada County Election's Office claiming the district's libraries contain sexually explicit material available to children, and the district has refused to change its policies about it.

The petition, which was accepted by the election's office, now goes to the Ada County Commission to decide whether to place the dissolution on the ballot.

The commissioners are scheduled to consider the request at 10 a.m. this Thursday, Feb. 16, in the commissioners' conference room in the Ada County Courthouse.

The petition was "a community effort," said Phil Reynolds in a Facebook message to the Idaho Statesman. Reynolds is one of the leaders of the effort to dissolve the library district, the Statesman previously reported. The Concerned Citizens' Facebook group had 204 members as of Wednesday.

Last summer, hundreds of people, some of whom were were part of the Concerned Citizens of Meridian, gathered at a Meridian Library District board meeting to voice their concerns about or support for books that were available to children. Most of the people who spoke during public comment supported the library, the Statesman reported.

The criticism of the Meridian library follows a nationwide trend where some conservative groups have accused local libraries of having sexually explicit material accessible to children.

The Concerned Citizens' petition said the library "contin-

ued the availability" of material targeted to "sexualizing minors." The petition also criticized the library for offering a space to meet for the Queer Straight Alliance, a group the citizens said supports the "sexual indoctrination of minors."

The group also wrote that the library board had refused to hear community concerns during its meetings, and that one library board member "supports the chemical and surgical castration of minors."

Meridian Library Director Nick Grove said by phone that the library is not prepared to comment on the petition before the commissioners' meeting.

Voters created the Meridian Library District in 1974 with a ballot measure. A year later, voters elected to tax their properties to pay for it. The district runs four libraries across the city on a \$7 million annual budget, and it anticipates opening another library next year, according to its website.

A news release from the county outlined the dissolution process for a taxing district:

- A petition must be filed with the Ada County clerk and presented to the commissioners.
- A petition requires at least 50 verified signatures.
- A hearing must then be held within three to six weeks.

- The commissioners must notify the public in a newspaper two weeks before the hearing.
- The commissioners must send notice to the governing board of the library district.
- The commissioners must issue an order 10 days after the hearing saying whether or not the county clerk must hold an election.

If voters dissolve the district, the commissioners would dispose of its property and assets, and any indebtedness would be placed in the county general fund, the news release said.

Many Idaho cities, including Boise, Nampa, Caldwell, Eagle, Garden City and Middleton, include libraries as part of city government, but some, including Meridian and Kuna, do not. The Meridian district's libraries are:

My name is Megan O'Rourke, I am a citizen of Meridian, and I am writing to oppose the petition to dissolve the Meridian Library District because it sets a dangerous precedent. If we restrict access to information because some disagree with it, we are paving the way for fascism.

I had the opportunity to travel to Munich, Germany, this past fall. I went on a tour of World War II landmarks, which included the Königsplatz. Between March and October 1933, numerous book burnings were held on that site. I don't need to recap the atrocities that followed, but the persecution of opponents of the Nazi regime began with the censorship of ideas a small, vocal minority opposed.

Tragically, more than 6 million people died before the Nazi reign of terror came to an end. But what is most remarkable to me is, despite the Nazi's best efforts, the people and ideas they sought to suppress survived. And 90 years after those Nazi rallies and book burnings, people have not forgotten those challenged and burned books. In fact, every May 10 the community comes together—on the Königsplatz—to read challenged or burned books.

As I learned on my trip to Germany, you cannot suppress ideas some people find distasteful because what is deemed distasteful is subjective. By dissolving the library district, you are effectively censoring the books and materials in question and endorsing one ideology. In this case, that ideology is grounded in hate and ignorance. Ira Keller once said, "The best defense against tyranny is a well-educated public." A wonderful place to combat ignorance is, ironically, a library.

In America, we value personal freedom and individual liberty. One of the greatest implications of our shared values is the fact that everyone has the freedom to choose for themselves and their families what is appropriate. To this end—the free expression of ideas—I urge you not to entertain this unconscionable effort.

This place is truly a community treasure and not only deserves to stay open but is necessary to continue to help community members.
