

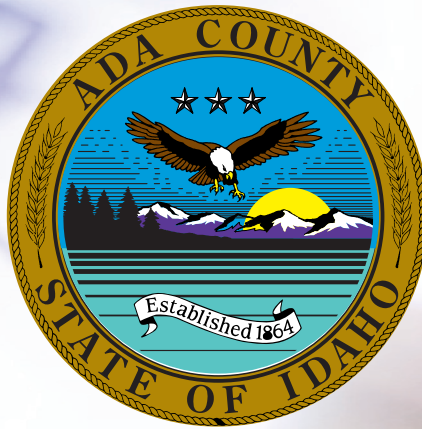
KEEP CONSTRUCTION DEBRIS SORTED

The Ada County Solid Waste Management Department encourages contractors to keep wood scraps separate from other garbage and construction waste generated at construction sites.

Currently, all adequately separated wood debris is recycled at Ada County's Hidden Hollow Sanitary Landfill. This recycling effort saves valuable landfill space and reduces dumping fees for builders who separate out their wood waste by 75%.



Landfill Wood Recycling Collection



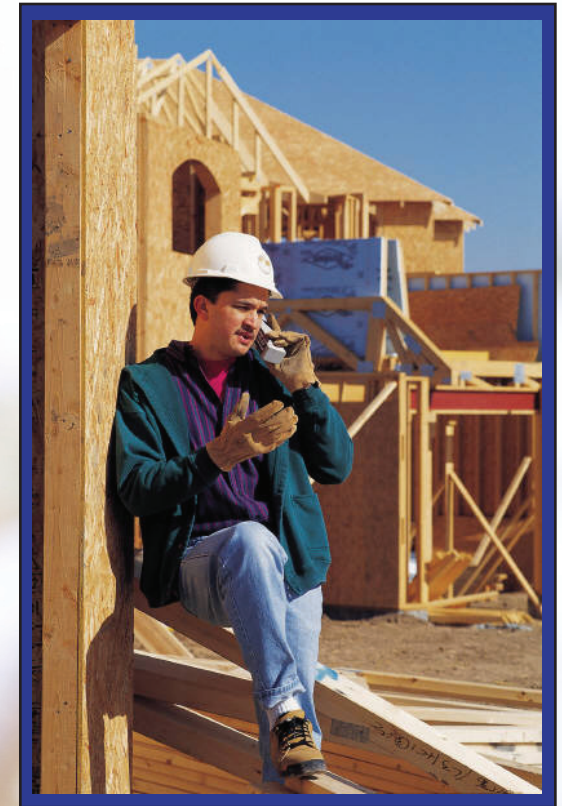

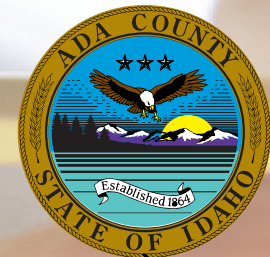

WHY YOU SHOULD KEEP YOUR CONSTRUCTION SITE NEAT AND CLEAN

As a developer or general contractor, you have an obligation to keep your job site neat, clean and free of any construction waste that could impact nearby property owners.

In Ada County, contractors are required to use a construction box or a franchised waste hauler's "roll off box" to collect and contain all construction waste. Builders who don't utilize this easy and effective method of keeping debris from spilling over onto adjacent properties have the potential of violating Ada County's Solid Waste Ordinance.

WHAT THE ORDINANCE SAYS

Ada County's Solid Waste Ordinance clearly defines a person's responsibility to maintain sanitary conditions

on their property. Section 5-2-4-2 of the Ordinance reads:

"All persons shall maintain their premises in sanitary condition. No person shall throw or deposit or permit to accumulate any waste in or on premises, improved or vacant, either public or private, within unincorporated Ada County, unless said premises is a disposal site, so that it constitutes a public nuisance under Idaho Code Title 18, Chapter 59."

PENALTIES FOR VIOLATING ADA COUNTY'S SOLID WASTE ORDINANCE

A deputized Ada County Health Protection Officer will issue a misdemeanor citation to anyone who violates the Ada County Solid Waste Ordinance. The citation requires the accused to appear in court before a judge.

Violators found guilty of the misdemeanor offense can receive 6 months in jail and/or a \$1000 fine.

Additionally, an Ada County Building Inspector may also issue a Stop Work Order until the situation is resolved.
