### 20.2. JURISDICTION PROFILE

The Independent School District of Boise City #001 was established in 1865 by the Governor of the Idaho Territory and predates Idaho statehood by 25 years. The District currently serves a population of roughly 205,000 residents of Boise City and Ada County. The District operates 57 facilities to serve a student population of approximately 25,000 Pre-kindergarten through 12th grade students.

<sup>5.</sup> Emergency Services: Actions that protect people and property during and immediately after a hazard event. Includes warning systems, emergency response services, and the protection of essential facilities.

<sup>6.</sup> Structural Projects: Actions that involve the construction of structures to reduce the impact of a hazard. Includes dams, setback levees, floodwalls, retaining walls, and safe rooms.
