INFORMATION / DISCUSSION ITEMS

Doug welcomed all attendees to the meeting and provided a brief overview of the agenda. He then turned the meeting over to Staff to give updates on recent activities.

- **Review of Findings from Recent Regional Exercises hosted by Ada County**
(PowerPoint Presented)

Joe opened the meeting by sharing the findings from the two recent regional exercises hosted by Ada County. He briefed the attendees on the Pet Sheltering exercise, which had a broad spectrum of attendees, and shared information on ASPCA, who assisted Joe in this training/exercise event. This exercise has had a spring-board effect ushering in a state contract with ASPCA which counties statewide could benefit from in the event of an emergency or disaster.

He then shared the findings of the SW Idaho Mass Fatalities exercise.

- **Progress Reports on 2016 Hazard Mitigation Plan, County-wide Enhanced Wildfire Risk Map Projects, and the Boise River Fifteen River Flows Internet Based**

Crash began his presentation by displaying our website, and demonstrating where The Ada County Hazard Mitigation Plan is located and also how to find information on the Hazard Mitigation Plan update that is currently underway. He shared that the 2016 Hazard Mitigation Plan is required to be updated every five years. As part of this discussion he then

shared the Enhanced Wildfire Risk Map Project that is underway, and what milestones have been accomplished to date.

- **Review Current Ada County Threat/Hazard Identification and Risk Assessment (THIRA) and Potential New Capability Targets as They Relate to the LEPC**
(PowerPoint Presented)

Joe presented the list of prioritized and set targets for multiple capabilities previously identified to address our threats and hazards of concern. The first responders have weighed in and have requested the inclusion of six additional capabilities. Joe briefed the attendees as to what they are and where they fit within the THIRA.

- **Annual Great Idaho Shakeout Presentation**

Myla gave an informative presentation on the Great Idaho Shakeout that will take place on 10/15/2015 at 10:15 a.m. She also shared the website location and a visual of the website for attendees to see.

- **Communicating in the 21st Century: Ada County Emergency Management's new Social Media Presence**

Myla provided information relating to ACEM's new Facebook page and Twitter account. She then displayed these new social media tools and provided a brief demonstration of how they look and work, for all attendees to see.

- **National Weather Service Summary and Review of the July 8, 2015 Weather Event**

Troy Lindquist of the National Weather Service provided an overview of the weather event that occurred on July 8, 2015 and went through a PowerPoint presentation that explained the event in detail.

Doug took a moment to introduce the attendees to the new Ada County Coroner, Dotti Owens, who in turn introduced her new Chief Deputy, Val Brisbin.
