ELECTRONIC MONITORING CONTRACT

I, the undersigned, have been ordered onto ELECTRONIC MONITORING in which I agree to participate. In order to participate in the program, I agree to abide by the following rules and conditions. Furthermore, I understand that violation of these rules and conditions may result in revocation from the program and immediate return to secure detention.

The Juvenile is subject to <u>all</u> of the following contract terms:

- 1. Said juvenile must meet with the Probation Officer, as directed, and will cooperate during these visits home, school, office, or otherwise and will provide documentation of work hours, school attendance and/or movements in the community as requested. Said Juvenile shall not leave the school campus during the day unless previously approved.
- 2. No visitors will be allowed at or in the home while on EM with the exception of family members.
- 3. Said juvenile shall obey all local and federal laws, and adhere to all conditions of the EM Program. New misdemeanor or felony law violations will result in an AUTO-DETAIN, which constitutes immediate clearance for Detention.
- 4. <u>Association:</u> Said juvenile shall have no avoidable contact with probationers, or any individuals not approved by the Probation Officer, parent or guardian including:______
- 5. <u>Fourth Amendment Waiver:</u> () Complete, () Partial as follows: random UA's and alcohol Breathalyzer. Said juvenile shall submit urinalysis/Breathalyzer tests as requested by the Probation Officer, at the expense of said juvenile or juvenile's parents. Said juvenile agrees to have no contact with drugs or alcohol.
- 6. If currently on probation, juvenile shall comply with all of his/her probation conditions.
- 7. I understand that I am not to leave the jurisdiction of Ada County unless otherwise authorized by the Court.

SPECIFIC ELECTRONIC MONITORING CONDITIONS

- 1. Fees for Electronic Monitoring:
 - a. \$20.00 hookup fee
 - b. \$1.00 per day land-line unit (or)
 - c. \$3.00 per day cellular unit
- 2. All Electronic Monitoring Equipment issued to said juvenile shall be returned to ACJCS within 24 hours of removal from the program, **including home monitoring unit**, **ankle transmitter**, **phone and AC power cords** in the same condition as it was issued. Failure to do so could result in legal/criminal action against the juvenile and parent/custodian. Further, I agree to allow the Probation Officers to enter my home, to install, maintain and inspect all assigned devices as required.

3. Said Juvenile and parent/custodian shall have all calling services removed from their phone line (used for electronic monitoring purposes) including, but not limited to Qwest Voice Messaging System (or in off position), DSL with a filter, and Privacy Block. Parent/custodians shall remove these services within 24 hours of signing this agreement, and provide verification upon request to the Probation Officer that all calling services have been removed. Parents/custodians who fail to remove these services or who reactivate them while said juvenile is on Electronic Monitoring may face legal action by the court.

Revised on 04/01/2011 JG RVSD VL, JT, DC, MS on 09/28/07 I understand that I must maintain continuous telephone services or it will result in a violation of the Electronic Monitoring contract. If power or phone services are removed from the residence, the Probation Officer shall be notified immediately.

4. I understand my participation in this program will be monitored by a tamper-alert ankle bracelet that I agree to wear 24 hours a day during my entire period of involvement in the Electronic Monitoring Program. I hereby waive my right to confidentiality to the extent I will be wearing a monitoring device which may be observable to other persons. Furthermore, I understand that the Probation Officer has my consent to notify my school and/or employer to advise them I am on EM for the purposes of checking attendance and conduct.

Removal of the transmitter from your body at any time will result in an AUTO-DETAIN, which constitutes immediate return to Detention. The only people who can remove the ankle bracelet are law enforcement personnel, emergency medical personnel, and ACJCS staff. Further, I understand that I will not move any monitoring equipment from its original location as it was installed, unless otherwise instructed, and use of extension cords or phone cords not provided are prohibited.

- 5. I agree to remain inside my home and IN RANGE unless the Probation Officer grants PRIOR verbal approval. I agree to either make, or have my parent or guardian make movement calls as directed by the Probation Officer.
- 6. I understand I must report directly to my authorized destination. I understand **ANY** moves not scheduled or approved prior to their occurrence by the Probation Officer will be considered a violation. Any invalid departures or unauthorized movements of any kind will be considered violations.
- 7. I understand the only exception to my pre-approved schedule is a medical emergency. The emergency must involve me or an immediate family member. Notification of the emergency must be made to the Probation Officer as soon as possible indicating the nature of the emergency.
- 8. I understand I will not operate a motor vehicle while on EM unless approved by the Probation Officer. I agree not to occupy any motor vehicle unless it is with an approved adult.
- 9. I understand that I will not leave school grounds unless I am attending an off-campus class or pre-approved appointment.
- 10. I understand that I am not able to participate in any type of water activity expect for showering and shallow baths. (ie: hot tubs, swimming pools, and floating the river are not allowed).

<u>PARENTAL RESPONSIBILITY</u>: Failure of any parent, guardian, or custodian to make reasonable efforts to ensure the juvenile's compliance with this court order may be punished as contempt, per I.C 20-522 and I.J.R. 25.
